# Good Standing Policy

## Statement of Policy

At Boyanup Primary School, the Good Standing Policy supports our values of *Endeavour*, *Integrity* and *Achievement* by acknowledging and rewarding exemplary student behavior. ‘Good Standing’ is reinforced by our Positive Behaviour Support Program which explicitly reinforces and teaches being an *Active Learner*; being *Responsible*; being *Caring & Safe* and being *Respectful*.

## Policy Aims

We aim to provide an environment that is physically, emotionally and intellectually safe for all members of our school community.

We seek to achieve this by;

- Enabling a learning environment that is welcoming, inclusive and collaborative which emphasizes the importance of students taking responsibility for the choices that they make and how these choices have an impact academically and socially on themselves and others.
- Implementing the Good Standing Policy to complement the whole school Behaviour Management Policy.
- Provide regular acknowledgement for students who consistently behave in accordance to Boyanup Primary School values.

# To Maintain ‘Good Standing’ ...

**Students must;**

- Comply with the Boyanup Primary School’s ‘Code of Conduct’.
- Follow Boyanup Primary School Chart of Behavioural Expectations. Behavioural expectations are outlined for the classroom, playground, at gatherings such as assemblies, toilets and during transitions.
- Follow instructions given by any staff member.
- Maintain appropriate behaviour for relief staff.
- Satisfactory attendance and punctuality.\*
- Adherence to Boyanup Primary School dress code.

**Attendance\***

- Satisfactory Attendance is deemed to be fulltime attendance at school, or in the event of an absence, a satisfactory explanation of the absence.
- An absence is defined as any non-attendance at a class when normal classes are in operation.
- An absence is considered unsatisfactory if not explained or the explanation provided, in the view of the school, as being inadequate or inappropriate.

It is the responsibility of each student to maintain their ‘Good Standing’ to be able to be included in extra curricular activities, including before and after school activities, specific lunch time ‘club’ activities, and sporting events held during school hours.

Students who lose their ‘Good Standing’ status will lose privilege to participate in various events throughout the school year including; excursions, camps, inter-school sporting events, sport days, whole class/school rewards.

Students who are student leaders may have their leadership role revoked for a period if they lose their ‘Good Standing’.

Students will lose the privilege to participate in activities where the safety of other students is a concern.

# Our Good Standing Policy

A student’s ‘*Good Standing*’ status will be withdrawn following consultation with the school leadership team, specialist staff and classroom teacher.

**Students will lose their ‘Good Standing’ as a consequence of:**

- Three office referrals being officially entered on Integris by the Principal or Deputy Principal with parents/guardians informed.
- Three detentions. This must be entered on Integris by the Principal or Deputy Principal with parents/guardians being notified.
- Three formal Withdrawals to admin. This must be entered on Integris by the Principal or Deputy Principal with parents/guardians being notified.
- Suspension

Parents and guardians of students ‘*at risk*’ of losing their ‘*Good Standing*’ will be contacted by the Leadership Team via a phone call and/or via letter.

**Regaining ‘Good Standing’ status:**

Students will regain ‘*Good Standing*’ at the end of a three week period demonstrating during this period expected behaviours that determine ‘*Good Standing*’.

The Good Standing Policy is provided to maintain consistency in our decision making processes. These are guidelines and exceptions may be made if there are extenuating circumstances that have resulted in negative behaviours.

## Severe Clause

Students will lose the privilege to participate in activities where the safety of other students is a concern. Any form of violence will result in the loss of ‘Good Standing’.

Students who are involved in a ‘one off’ severe behavior incident in the classroom or playground will automatically lose their ‘Good Standing’.
